EC was informed by NTI that no new Cultural Assessments will be done, including one for the Irniurviit ACMC, until finalizing the renegotiation of an IIBA.

Concerns were raised as it was a commitment under the first IIBA and the ACMC needs the information to inform the management plan. There is confusion about what information NTI plans to collect and what the ACMC should collect in the meantime. The ACMC is concerned that there the number of elders is decreasing in the community, in particular those that might have valuable information about Ikkattuaq.

A/I – Inform KIA of the situation. Also, inquire with them about a possible KIA-led project summarizing human activity and wildlife areas that was conducted ~3 yrs ago.
