1. Meeting opened with a prayer by Atsiaq.
2. Introduction around the table.
3. Welcoming Remarks:  
Martha – Welcomes everyone attending the meeting, knowing today is a Sunday but we would like to take this opportunity to meet with Jim Leafloor who has conducted work on banding geese in Dewey Soper for the past few years and will talk to us about Dewey Soper MBS. This was the only time we could have scheduled the meeting with Jim and I thank him for coming here.

4. Delegation –Jim Leafloor, thank you for inviting me to meet with the ACMC for Dewey Soper. I will be presenting on Dewey Soper MBS about the learning Context from a national/international expert of the importance of the area at the National and global scale. If anyone has any questions during my presentation, please feel free to ask anytime.

Some concerns from the ACMC members were mentioned such as; summer seasons seems to be getting longer and that means the snow geese are staying longer periods and eating more (berries). The snow geese also seems to be traveling more towards Kimmirut and Iqaluit area probably because of the habitat; also mentions that they are located more snow geese even around the hills eating berries (we don't normally see them around the area).

Break for lunch.

Meeting resumes; more talk about the presentation, one of the ACMC asked if it is possible to have another sanctuary for another bird species such as; eider duck?

One of the ACMC members also mentioned that more polar bears have been located around the area and last year, most of the eggs were destroyed by polar bears. There is no vegetation for caribou around Dewey Soper MBS but that is the main trail for caribou migration.

Also, mentions that the bigger snow geese that fly from Pond Inlet fly at a really high altitude over Cape Dorset and that that are different geese.

Martha -Asked the ACMC Members of what they thought about Jim's presentation.

Members were really interested about the presentation, they now have a better idea about the birds coming from the south, how it has an impact down south about the feeding grounds and how they destroy the farm land and the noise can be of disturbance. They were truly surprised of millions of birds in the picture, they thought the birds that come up here are a lot but it is a very small number compared to the millions of birds that migrate up north.

No further questions/comments about presentation so moving along the agenda.

Martha – Let's talk about the report on Arctic Goose Banding Permit Application from CWS, it would be for 3 years, same presentations were done in the other two communities, Arviat & Cambridge Bay for the same permit application by Jim. ACMC Members had couple of questions such as; if a bird was found dead with a band on it, does it still have to be reported; if a band has been on for number of years, would that have an affect on the bird/leg?

Jim clarifies to the ACMC members that the bands are safe, never had any difficulties and that they fall off on their own, can be attached for up to 20 years.

No further questions about the permit application.

Olayuk moves to approve the Permit Application and rest of the ACMC's approve of the permit application.

Permit to be issued to Jim Leafloor.

#### 5. Annual work plan for the ACMC

There was brief discussion about the goals/objectives from the ACMC's that they want more community knowledge about the Sanctuary and for tourist attraction. We also talk about a possible site visit in August 2013 after Jim has finished his Banding geese and bringing the ACMC's to the Sanctuary when sending the Researchers back home.

We also talked about hosting a radio show and put up posters or notices about having an open house to introduce the Dewey Soper ACMC Committee to the community of Cape Dorset to make sure the public is aware of the Dewey Soper MBS.
