- A two and a half day meeting was held in Grise Fiord, April 21 – 24, 2017

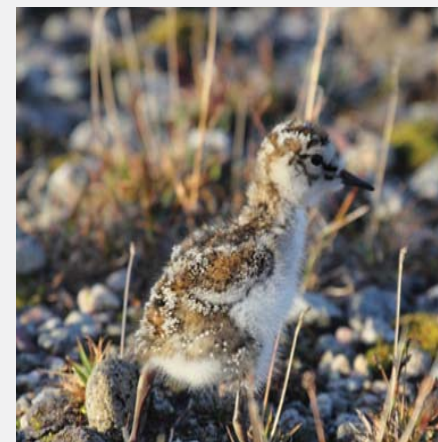
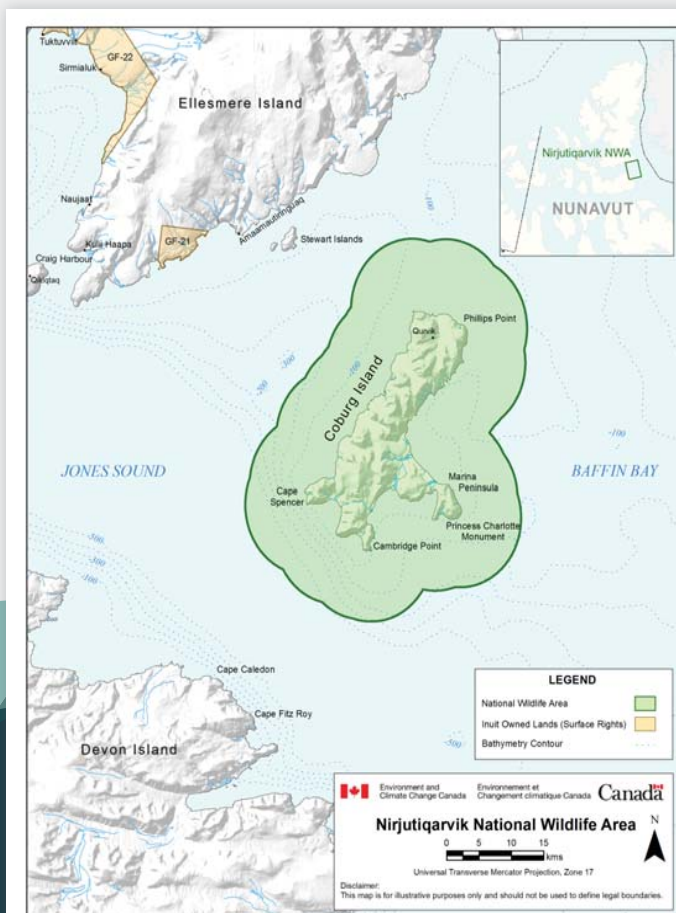

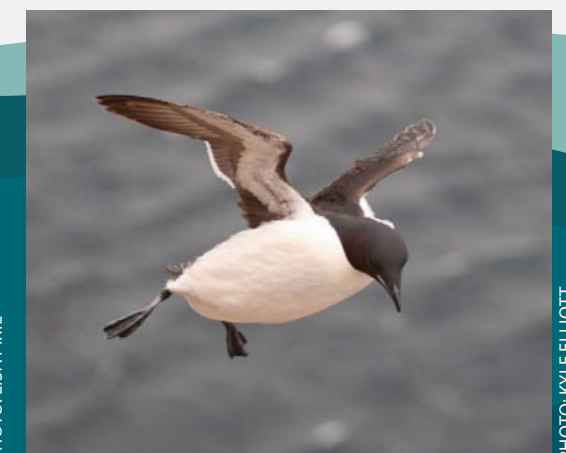
